#### 1. Title of the session:

Strengthening Enabling Conditions for Food Systems change through Policy Mechanisms

#### 2. Type of the session:

**Investment Dialogue** 

#### 3. Date and time of the session:

12:00 - 12:50, 28 July

#### 4. Session background (max 300 words):

This session will facilitate dialogue between governments, industry, and civil society with the aim to strengthen collaboration to accelerate towards healthy, sustainable and just diets. Through shared insights and real-world examples, participants will discuss key enablers of trust and alignment, helping to identify pathways to drive food systems transformation. Ultimately, this session aims to bring together participants from the public and private sector to collaborate to accelerate food systems transformation.

#### Context (max 300 words):

Trust, transparency, and clear roles are essential to translate national food systems strategies into effective multi-stakeholder implementation. When government leadership is followed by company commitment, it is possible to align political, commercial, and societal goals. Policy mechanisms—including fiscal incentives, standards, and public procurement—can reduce investment risks. This creates conditions for action that can enable political support, reduces market uncertainty, and accelerates the shift toward healthy, sustainable, and just diets.

#### 5. Session objectives:

- Showcase real-world examples of policy and investment mechanisms driving shifts toward healthy, sustainable, and just diets aligned with national food systems strategies.
- Identify key enablers and practical recommendations for governments and corporate investors to align around common goals and clearly defined roles.
- Explore effective approaches to building trust, accountability, and multistakeholder collaboration that support the implementation of national food systems strategies.

#### 6. Link UNFSS+4 objectives



**Unlocking Finance and Increasing Investments:** Surface best practices of collective action between businesses and policy makers that align with healthy, sustainable and just diet goals.

#### 7. Key message(s) of the session:

- Policy mechanisms are essential to create the enabling environment needed for food systems transformation.
- Well set-up and executed multi-stakeholder collaboration can accelerate implementation of national food systems strategies.
- Examples from across the value chain show how coherent policy and governance can unlock investments.

Panel discussion (brief Q&A)

#### 9. Guiding questions for speakers:

- How can governments and the private sector effectively collaborate within their respective roles to support policies that advance healthy, sustainable and just food systems?
- What examples of successful partnerships between governments and private sector have advanced food system transformation? What lessons can we learn to scale these partnerships?
- How can private sector and governments work together to reduce risks and increase investments that accelerate the shift towards healthy, sustainable and just diets?

#### 10. Desirable outcome:

Through a dialogue between government and business leaders, the session will identify key mechanisms that have proven effective in shifting markets toward more sustainable consumption patterns through successful collaboration. By showcasing real-world examples, it will demonstrate how coherent governmental leadership can unlock investment, de-risk innovation, and scale solutions across the food value chain. Finally, this session will support country-led implementation by surfacing examples that are adaptable, scalable, and aligned with national food system transformation pathways.
