Transforming agriculture & food systems is a key part of the global solution to climate change. Climate change poses physical risks to agrifood systems, exacerbating food insecurity, reducing crop yields and disrupting supply chains, amongst other negative effects. At the same time, our agrifood systems are contributing to 1/3 of global emissions. Regenerative agriculture represents a mechanism that businesses – and other actors – can use to decarbonize our agrifood systems.

Leading businesses are already taking action at the landscape level, for instance through the Action Agenda on Regenerative Landscapes and the Landscape Accelerator – Brazil. However, public-private collaboration is necessary to scale these models further and transpose them to different geographies, tailoring them to local contexts
