Day 1 of the Stocktake will offer space for the highest political leadership to reflect on global developments and their relevance to realizing the right to food in national contexts, highlighting various drivers and root causes, and reaffirming the necessity to pivot towards more sustainable food systems through a multilateral approach. Inspiring experiences of impactful policy convergence will be shared by decision makers, while practitioners will discuss the enablers and barriers. Given the importance of finance and investments for accelerated efforts at scale, discussions will build on the outcomes of the Financing for Development (FfD4) Conference.
